#### **Processes:**

- 1. Scenario Planning: Have we outlined and prepared for various scenarios, including low-probability ones?
- 2. **Expert Consultation:** Are we regularly consulting experts to base decisions on current understanding and data?
- 3. Ongoing Risk Assessment: Are we continually assessing risks to adapt to changing situations?
- 4. Use of Decision Support Systems: Are we using tools for objective, data-driven decision-making?
- 5. Frontline Feedback Loop: Do we maintain open communication with frontline for real-time insights?

#### Addressing Personal Agendas and Biases:

- 1. **Rationale Explanation:** Can you explain the rationale behind this approach?
- 2. Evidence Basis: What data or evidence supports this decision?
- 3. Goal and Value Alignment: How does this align with our overall goals and values?
- 4. **Alternative Viewpoints:** Have alternative viewpoints been considered?
- 5. **Stakeholder Impact:** How does this decision impact different stakeholders?
- 6. **Comparison with Standards:** How does this choice compare with industry standards or best practices?
- 7. **Decision-Making Contributors:** Who else has been involved in this decision-making process, and what were their contributions?
- 8. **Review Mechanisms:** What mechanisms are in place to review or audit this decision?
- 9. **Conflict of Interest Check:** Are there any potential conflicts of interest that could be influencing this decision?
- 10. External Explanation: How would we explain this decision to someone outside our organization?

- 3. Concrete Action Plans: Have specific action plans been developed to address the identified gaps?
- 4. **Responsibility Assignment:** Is responsibility clearly assigned for implementing the action plans?
- 5. **Timelines and Milestones:** Have specific timelines and milestones been established for implementing corrective measures?
- 6. **Implementation Monitoring:** Are the action plans being regularly monitored for progress and effectiveness?
- 7. **Communication of Findings:** Have the findings, causes, and action plans been shared with relevant stakeholders?
- 8. **Continuous Improvement Integration:** Have the lessons learned and actions taken been integrated into continuous improvement processes?
- 9. **Effectiveness Evaluation:** After implementation, have the actions taken been evaluated for their impact on closing the identified gaps?
- 10. **Documentation:** Have the analysis, actions, and outcomes been thoroughly documented for transparency and accountability?
- 11. **Independent Review (if necessary):** Have we considered an independent review for significant gaps or concerns about internal biases?
